RFIS FROM PROPOSERS (Q) AND RESPONSES FROM SVCW (A)

(Q1) With reference to Section 6.3.2 – Firm Qualifications, “Include number of experiences and reference contacts (phone and email) for these projects.”: Is there a minimum number of projects that should be included to demonstrate our experience?

(A1) No minimum number of projects is required.

(Q2) With reference to Section 6.3.3 – Team Qualifications, “Provide reference contacts (phone and email) for previous, similar work performed by key project personnel and their role on those reference projects.”: Is there a minimum number of references for each key project personnel?

(A2) No minimum number of references is required, but a maximum of two (2) references per project are specified.

(Q3) Will we have the opportunity to add or adjust team members on our organizational chart during the RFP stage as we refine our project approach, or is the SOQ the only stage where we can present our team and their qualifications?

(A3) Team members may be added, but not removed, at the RFP stage.

(Q4) We are not familiar with your contracting terms, could you provide a sample professional services agreement including insurance requirements so we can review it prior to submitting our SOQ?
